Means and Devices for Medical First Aid for Workers in the Institution - 2024



Employer's Responsibility

The employer must make the necessary arrangements for first aid in accordance with the Labor Law and the regulations and instructions issued under it. This should ensure that first aid is provided as quickly as possible, with proper attention to equipment and facilities, and that these arrangements are communicated to all workers.

► Medical First Aid Equipment and Devices for Workers

Medical first aid equipment and devices must be available at all branches of the institution and work sites where economic activities are carried out, as follows:

Economic Activity Risk Level	Number of Workers	Minimum Number of First Aid Kits/Bags
Low Risk	1-100	1
	101-500	2
	501-1000	3
	Each additional 1000	3
High Risk	1-50	1
	51-100	2
	101-500	4
	501-1000	6
	Each additional 1000	6

The first aid equipment must be kept in a box or bag in a visible and safe place that is easy to access, with guidance signs in place. The contents should be regularly checked to ensure validity, quantity, and replaced or replenished when necessary.



Additional Equipment Requirements

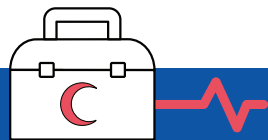
The employer must provide an **Automated External Defibrillator (AED)** at work sites where the number of workers ranges from **501 to 1000**, regardless of whether the institution is classified as low or high risk. It is also recommended to provide AEDs at sites with fewer workers due to their importance in enhancing medical emergency response.



At least **one blood glucose testing device** must be provided at each branch or work site where the institution conducts economic activity.



► Contents of the First Aid Box/Bag

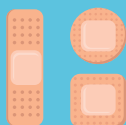


Each first aid kit must include at least the following:

1. An informational leaflet listing contents and general first aid instructions



2. Medical adhesive bandages in various sizes



3. Medical adhesive tape



4. Triangular bandage



5. Compression bandage



6. Multi-injury dressings



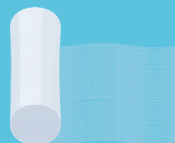
7. Burn dressings



8. Cut gauze



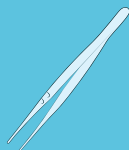
9. Gauze rolls



10. Medical scissors



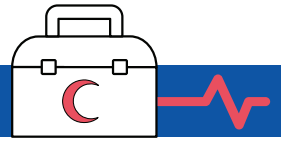
11. Medical tweezers

First Aid Training Requirement

The employer must train at least 2% of the workforce in low-risk economic activities, and at least 4% in high-risk activities on first aid.
